## **Ancestors of James Pinkney Roebuck**

This chapter shows the ancestors of James Pinkney Roebuck, following paternal lines dating back to 1722, and possibly, about 1695, all in the United States. The Roebuck name is presumed English. While there are many spellings of the name, this family line has seen Roebuck and Robuck mostly. Those wishing to perform further genealogy study might look for other spellings including Robuk, Robuc, Rabuck, and Roebucke in England.

Example 1–1 shows an overview of the paternal progression of ancestors from Robert Roebuck to James Pinkney Roebuck, including birth years. Note that the Robert Roebuck (b. 1695) is presumed to be the father of George (b. 1722) but this is not confirmed.

#### **1.1 Robert Roebuck**

Robert Roebuck was born about 1695 in Northumberland County, Virginia. He died September 7, 1750 in Northumberland County, Virginia. The relationship of Robert Roebuck to George Roebuck (b. about 1722-1726) is probably father-son but it is not certain. The dates of birth make this plausible. At that time, the name was most likely spelled Robuck. His wife's name is unknown.

On October 25, 1710 there was a fire at the Northumberland County, Virginia Court House which probably destroyed the only records that might establish, with certainty, the name of the progenitor of the Roebuck line in this document.

Records for the years 1706-1710, which had burned, were re-recorded by citizens though no wills are in these records. However, there is a probate record of a will of Robert Roebuck, probated July 20, 1709, with a Robert Roebuc as his presumed son and executor. The record does not name other children.

The records and baptisms of the family would have, typically been in parish registers of the Wiccocomoc Anglican or Established church, the only legal church prior to the Revolution, though, these books are not known to exist.

Alternatively, it should be considered that there is another possible line of parental ancestors of George Roebuck. Example 1–2 shows that possible lineage.

#### 1.2 George Roebuck (1)

George Roebuck was born between 1722 and 1726. His birth place is not known with certainty but it may have been Northumberland County, Virginia. His father's name may have been Robert Roebuck. His early life was spent in Virginia, and later he was of the Spartanburg District, South Carolina. First records on him date to 1743. He died between 1781 to 1783 in a British Prison in Camden, South Carolina.

George Roebuck married Mary Warren, who was born about 1726 to 1731 in Orange County, Virginia. They were married about 1751/1752 in Orange County, Virginia. The first records of them are in Orange County. Mary died in about 1795.

Children of George Roebuck and Mary Warren:

He was a Lieutenant in the Revolutionary War and was at the Battle of Musgroe's Mill on August 18, 1780. At the Battle of Mud Lick, March 21, 1781, he was wounded and captured. He was taken to Charleston and later exchanged for British soldiers. It is thought that he contracted tuberculosis during his imprisonment and later died of the disease. Many accounts can be found of Benjamin.

2. Frances "Frankey" Roebuck, b. about 1755/1756 in Orange County, Virginia; d. 1820-1830 in Spartanburg County, South Carolina; m. John Vice

Frances Roebuck married John Vice about 1772/1773. John was born in Orange County, Virginia about 1755. John and Frances are in Spartanburg County, South Carolina by 1810 according to the U.S. Census. They are also listed on the 1820 U.S. Census in Spartanburg County.

For more information about the will of John Vice, which lists his wife, see Appendix B, "References" item #4 on page B-4.

#### 1.3 Mary Warren

Mary Warren, a daughter of William Warren and Elizabeth Ham or Hackley, was born about 1725 to 1731, in Orange County, Virginia. She married George Roebuck (1) about 1751/1752 in Orange County, Virginia. The first records of them are in Orange County in 1743. Mary was widowed and lived a number of years after George's death. She died sometime before 1795. Mary is mentioned in her husband's will, having deeded her a track of land. She is later mentioned on November 11, 1795 in a land deed of her son George Roebuck (2) as deceased.

Section 1.2, "George Roebuck (1)" shows children of George Roebuck and Mary Warren.

#### 1.4 George Roebuck (2)

George Roebuck, son of George Roebuck and Mary Warren, was born March 15, 1757 in Orange County Virginia and died May 2, 7, or 17, 1848, in Spartanburg District, South Carolina. George married Lavina [Levina] Bobo in about 1781 in Spartanburg County, South Carolina.

#### 1.5 Lavina Bobo

Lavina [Levina] Bobo, daughter of Sampson Bobo and Sarah Mary (Sally) Simpson, was born about 1762 in Albemarle, Virginia and died between 1820 and 1830, in Spartanburg County, South Carolina. Some records show her death as late as 1849 in Spartanburg County, South Carolina but neither of these records is verified.

Lavina's father Sampson Bobo served in the military in Col. Brandon's Regiment South Carolina. Sampson Bobo was born about 1735 and died April 17, 1804. He married

Sarah Mary "Sally" Simpson on April 16, 1763. The Bobo line can be traced back to French roots with a spelling of Beaubeau and Beaubeaux. For more information on the ancestors of Lavina Bobo, see Section A.3, "Lavina Bobo" on page A-2.

Section 1.4, "George Roebuck (2)" shows children of George Roebuck and Lavina Bobo.

#### 1.6 John R. Roebuck

John R. Roebuck (Robuck), a son of George Roebuck and Lavina Bobo, was born on June 20, 1800, in Spartanburg County, South Carolina. He died about 1868 and is buried in the Beulah Baptist Church Cemetery in Greene County, Alabama in an unmarked grave.

John Roebuck married Jane A. Reynolds, a daughter of Gideon and Mary (Rogers) Reynolds. They were probably married in Spartanburg County, South Carolina. They migrated to Alabama some time before 1836 when John Reynolds purchased land in Greene County, "Section 2, Township 23, Range 2E." This purchase was made on February 4, 1836 in Tuscaloosa, Alabama.

Jane died young at the age of 21 or 22 on September 27, 1837 leaving three children, ages, 5, almost 4, and 1. There is evidence in the will of Jane's father, Gideon, that the children lived with her parents. There was a claim for boarding the Roebuck children made in the January 1861 Court in Greene County Alabama in the Will Book B, p. 234, Estate file #1172.

#### 1.7 Jane A. Reynolds

Jane A. Reynolds, a daughter of Gideon Reynolds and Mary Rogers, was born about 1815 in Spartanburg County, South Carolina. Jane died young at the age of 21 or 22 on September 27, 1837. She is mentioned in her father's will. Gideon Reynolds, lists "three grandchildren of deceased daughter, Jane A. Robuck" in his will which was probated in Greene County, Alabama on October 14, 1839.

There is evidence in the will of Jane's father, Gideon, that the children lived with her parents after her death. There was a claim against John R. Roebuck for boarding the Roebuck children made in the January 1861 Court in Greene County Alabama in the Will Book B, p. 234, Estate file #1172.

Gideon Reynolds was a Major in the Confederate Army. Gideon Reynolds was born about February 2, 1776 in Frederick, Virginia and died in Greene County, Alabama on June 10 1839. Mary Rogers was born June 16, 1778 in Spartanburg County, South Carolina and died November 29, 1860. Gideon Reynolds and Mary Rogers are both buried in Beulah Baptist Church Cemetery in Greene County, Alabama.

#### **1.8 William Pinkney Roebuck**

William Pinkney [Pickney in some records] Roebuck, a son of John R. Roebuck and Jane A. Reynolds, was born on June 22, 1832, in South Carolina and died June 20, 1912 in Greene County, Alabama. He lived most of his life in Greene County, Alabama, moving with his parents around the age of 2, in 1834. William was primarily a farmer and also a caretaker for the Beulah Baptist Cemetery where he was a member for more than 50 years. He was married twice.

He joined the Confederate Army in 1861 and was part of Company B, 11th Alabama Regiment. After the war he received a Confederate Army pension. He is buried in Beulah Baptist Church cemetery.

William Roebuck married Nancy Jane Roberts on January 3, 1867. Greene County Probate office records, 1867, Vol C-1 page 421 show that they were married by Rev. M. P. (Mathew Pickett) Smith "at the residence of her mother." Within a year, Nancy had a child who died at birth. She died shortly after.

Thirteen months after his first marriage, William married Nancy Jane Cockrell, daughter of John Cockrell and M. Liza Roberts, on February 27, 1868. Greene County Probate office records, 1867, Vol C-1 page 416 show that the license was granted on February 25 1968 and solemnized on February 27, 1868 by M. P. (Mathew Pickett) Smith "at the residence of the Bride's Father."

The only child of William Pinkney Roebuck and Nancy Jane Roberts is:

William (Bill) Smith Roebuck and Hattie Bell Crocker are both buried in the Beulah Baptist Church Cemetery.

Miriam Collins, great granddaughter of James Pinkney Roebuck says that her mother, Nancy (Nan) Elizabeth Roebuck and her Uncle John Pinkney Roebuck, the <sup>&</sup>lt;sup>1</sup> The family was enumerated on the 1880 U.S. Census. William was listed as a farmer and Nancy as a homemaker.

children of James Pinkney Roebuck and his first wife, Martha Louvenia (Lou or Loula) Storey, were raised by Aunt Vine after their Mother's death in 1895.

Jeremiah (Jerry) C. Roebuck, b. August 24, 1875; d. about 1953; m. Minnie D. Crocker

Minnie D. Crocker was born on November 9, 1879 and died on July 15, 1968. The author met Aunt Minnie in 1964. She was 84 or 85 at the time and lived in a old unpainted farmhouse in Greene County. The stunning part of the extremely rustic farmhouse was that it had a new gleaming pink ceramic tile bathroom.

Aunt Minnie chawed tobacco and the juice would run down the fold at the side of her mouth. It was quite a site for the author to see Aunt Minnie lift the lid on a large enamel-ware pot (slop bucket) and spit into it.

Jeremiah (Jerry) C. Roebuck and Minnie D. Crocker are both buried in the Beulah Baptist Church Cemetery

 Walter Raleigh Roebuck, b. December 24, 1878; d. aboout 1951; m. Annie M. Thomas

Annie M. Thomas was born about 1886 and died about 1979. Walter Raleigh Roebuck and Annie M. Thomas are bothe buried in the Beulah Baptist Church Cemetery.

#### 1.9 Nancy Jane Roberts

Nancy Jane Roberts, a daughter of John W. Roberts and Martha Pacey Pool, was born about 1840, possibly in Union, Greene County, Alabama. Nancy's father, John W. Roberts, was born about 1805. Not much else is know about Nancy. It is possible that she is buried in Beulah Baptist Church Cemetery in an unmarked grave.

Nancy J. Roberts married William Roebuck on January 3, 1867. Greene County Probate office records, 1867, Vol C-1 page 421 show that they were married by Rev. M. P. (Mathew Pickett) Smith "at the residence of her mother." Within a year, Nancy had a child who died at birth. She died in child birth or shortly after.

Section 1.8, "William Pinkney Roebuck" shows the child of William Pinkney Roebuck and Nancy J. Roberts who died as an infant.

#### 1.10 Nancy Jane Cockrell

Nancy Jane Cockrell, a daughter of John Cockrell and M. Liza [Elizabeth] Roberts was born October 20, 1837, probably in Greene County, Alabama, and died October 1, 1881. Nancy is buried in the Beulah Baptist Church Cemetery and is incorrectly listed on the grave stone as Nancy *E*. Roebuck.

She married William P. Roebuck on February 25, 1868. Greene County Probate office records, 1867, Vol C-1 page 416 show that the license was granted on February 25, 1968 and solemnized on February 27, 1868 by M. P. (Mathew Pickett) Smith "at the residence of the Bride's Father."

Nancy Cockrell's father was likely born about 1790. The date if his death is unknown but is often confused with another John Cockrell who died on August 6, 1866 and is buried in Pleasant Hill Cumberland Presbyterian Church Cemetery in Clinton, Greene County, Alabama.

Eutaw, Alabama Probate Records show the marriage of Nancy's parents as September 8, 1833, married by Reuben Tankersley, JP. in 1833 Vol. B, Page 61.

#### 1.11 James Pinkney Roebuck

James "Pink" Pinkney Roebuck, a twin son of William Pinkney Roebuck and Nancy Jane Cockrell was born on January 6, 1870 in Clinton, Greene County, Alabama. The story of James' birth, according to Clara Pink Roebuck, his daughter, is that both babies were "laid out for dead" and that the attending midwife noticed some movement in James and brought him to life. James lived his lifetime in that area and died on February 8, 1953. James was primarily a farmer and also a caretaker for the Beulah Baptist Cemetery. He married twice.

The first wife of James Roebuck was Martha Louvania (Lou or Loula) Storey, who was born October 17, 1875 and died December 9, 1895. According to Probate court records in Eutaw, Alabama, a marriage license application was granted by Probate Judge Wm. C. Oliver on December 19, 1892 and the marriage was solemnized on December 21, 1892. Beulah Baptist Church records show they were married at the residence of Robert Storey by Minister John G. Ahsey. Their the marriage license lists "James P. Robuck" and "M. Lavinia Storey."

The second wife of James Roebuck was Martha (Mattie) Elizabeth Flanagan, born August 27, 1878 and died June 29, 1941. According to Probate court records in Eutaw, Alabama, a marriage license application was granted by Probate Judge Amand P. Smith on December 15, 1900 and the marriage was solemnized on December 19, 1900. Beulah Baptist Church record show they were married at the residence of John Flanagan, Mattie's father, by Minister J. E. Herring.

James, Loula, and Mattie are buried at Beulah Baptist Church cemetery. James and Mattie are in the Roebuck plot and Loula is buried elsewhere in the cemetery.

**Note:** Verbal family history strongly indicates that the original records of the children's births, made in the family Bible, were destroyed, possibly in a fire. The birth records were re-recorded, from memory, in a new Bible.

In viewing a copy of that re-recorded Bible page, it is clear from the handwriting that the entries prior to 1914 where written at the same time by the same person.

This re-recording from memory lead to a number of actual and possible inaccuracies. These inaccuracies incluce the following:

- Nannie Elizabeth Roebuck is actually Nancy Elizabeth Roebuck
- Clara Pink Roebuck was born on November 29, 1912, not 1913. This is verified by birth records at the Alabama Vital Records Office.
- Clara Pink Roebuck may have been Clara Pinkney Roebuck but the record has now been permanently amended to "Pink."
- Louise Adelle Roebuck may be Louise Adele Roebuck.

#### 1.12 Martha Louvania (Lou or Loula) Storey

Martha Louvania (Loula or Lou) Storey, a daughter of Robert Cunningham Storey and Sarah Elizabeth Burnett, was born October 17, 1875 and died December 9, 1895. According to her granddaughter, Miriam Collins, daughter of Nancy (Nan) Elizabeth Roebuck, Lou died of a typhoid epidemic that swept the country in the years between 1895 and 1905. In 1895, it was the sixth most prevalent cause of death in Alabama, though it was probably more prevalent than that because many typhoid deaths may have been attributed to pneumonia.

Martha Louvenia may have gotten typhoid tending to others who were ill. Typhoid also took her sister, just 10 days after her death, her father, Robert Cunningham Storey, in June of 1895, and her other siblings except for Nora Storey.

She is sited in the "Beulah Church Book," on page 252, (covering 1819-1920) in most eloquent text about her passing:

"Sister Loula Ro[e]buck 'nee' Storey died Dec. 9 1895. She was born October 17 1875; joined this church by experience and baptism Nov. 1888 and was united in marriage to Bro. J.P. Ro[e]buck Dec. 21, 1892. As a daughter she was dutiful and mother tender and affectionate. She died as she lived trusting in the Lord as is shown by the following verse which she repeated a few minutes before she died. 'Come loving

Redeemer and take to Thy breast, The heart that is sighing and painting for rest; Blest Savior I am watching and waiting for Thee, Then O! let me anchor beyond the dark sea.' When the husband and children would mourn for her we would point them to this verse which indicates that she has gone to rest."

Sadly, her younger sister, Florence, died just 10 days later.

Martha Louvenia was the first wife of James P. Roebuck. According to Probate court records in Eutaw, Alabama, a marriage license application was granted by Probate Judge Wm. C. Oliver on December 19, 1892 and the marriage was solemnized on December 21, 1892. Beulah Baptist Church records show they were married at the residence of Robert Storey by Minister John G. Ahsey. Their the marriage license lists "James P. Robuck" and "M. Lavinia Storey."

#### 1.13 Martha (Mattie) Elizabeth Flanagan

Martha Elizabeth Flanagan, the first child of John Mitchell Flanagan and Roberta Annie MaHaffey, was born August 25, 1878, in Clinton, Greene County, Alabama. She lived her life in Clinton and Union (near Beulah) and died June 29, 1941.

Before Mattie married, she was a member of the Clinton Baptist Church and was baptized there.

Mattie married James Roebuck, a widower with two children. According to Probate court records in Eutaw, Alabama, a marriage license application was granted by Probate Judge Amand P. Smith on December 15, 1900 and the marriage was solemnized on December 19, 1900. Beulah Baptist Church record show they were married at the residence of John Flanagan, Mattie's father, by Minister J. E. Herring.

Mattie taught school at Union and West Greene schools though there is no record that she graduated from teacher's college (usually a one year degree at the time). She came from a family of well-educated girls, unusual for the time.

Mattie is recorded in the *Beulah Baptist Church Record* book as having taught Sunday School there until about 1904. We see her again in the records in 1919 when she and her daughter, Jamie Clara Roebuck, were part of the Beulah Woman's Missionary Society organized October 21, 1919. "The officers of this society are Miss A. G. Chambers, President; Mrs. Mattie Robuck, Vice President,; and Miss Jamie Robuck, Sec. Treasurer."

#### 2.4 George G. Storey, Sr.

George G. Storey, Sr., a son of Anthony Storey and Margaret \_\_\_\_\_\_, was born about 1724/1725 in Chester County, Pennsylvania. He died about 1805 in Fairforest, Spartanburg County, South Carolina. He married Nancy Cantor in 1744/1745 in Virginia.

George G. Storey, Sr. was granted land by King George III of England. "Two Hundred acres, Surveyed for him 6th Mary 1767. Situate in Craven County on a Branch of Fair Forrest, Waters of Broad River. Bounded to the North by land of the said George Storey, all other side by vacant Land." See list item number 2 on page B-2 in Appendix B, "References" for details of this land grant.

Henry served in the Revolutionary War as a Sergeant in Robert Ferris's Company, also as Sergeant Quartermaster in Matthew Put-on's Company. (Record No. X 1301). He also drove a team during 1778 (No. X 893). Henry was the only one of the brothers who lived long enough to receive a Revolutionary War pension. He received a total of \$120.00 per year for three years under Act of Congress November 7, 1832.

Henry received a grant of land from the State in 1785 adjacent to his father's property, and later sold it to his nephew George.

He moved to Greene County, Alabama in 1818, settled in Pickens County, and died in Greene County on March 19, 1837. He is likely buried in the Baron Presbyterian Church Cemetery, in Greene County, Alabama.

Henry's wife, Elizabeth Cunningham was born in North Carolina in 1764. There is a story that Elizabeth had a narrow escape from the Indians when she was a child. She was the sister of Catherine Cunningham, wife of James Storey, and her brother was Dr. Robert M. Cunningham, who was born September 10, 1760 in York County, Pennsylvania and died July 11, 1839 at Tuscaloosa, Alabama. Dr. Cunningham was the first pastor of the First Presbyterian Church at Tuscaloosa. Elizabeth died at the home of her son James in November, 1849.

About June or July 1776, a fortification for protection against the Indians was built on his father's place, called Storey's fort, and was in what was afterwards called Spartanburg District, South Carolina. In that year, he enlisted in the American Revolutionary War militia and served one year as a private in Captain Robert Faris' South Carolina Company.

In the Spring of 1778 he enlisted and served two months and ten days as sergeant in Captain Matthew Patton's company in Colonel John Thomas' South Carolina Regiment. In the Spring of 1779 he served two months as wagoner under Colonel Thomas Brandon. In the Summer of 1779, he served about five weeks as orderly sergeant in Captain Blossengem's South Carolina Company. He enlisted in November or December, 1779, as a Private in Captain John Thompson's company in a South Carolina Regiment under Lieutenant Colonel James Steene.

He was appointed Quartermaster by Nicholas Curry who was then issuing commissary and served in that capacity for two months and ten days. He enlisted about the first of May, 1780, and served until the end of the Revolutionary War as Sergeant in Captain Matthew Patton's company in Colonel Thomas Brandon's South Carolina Regiment and was in the battles of Musgroves Mill, Kings Mountain, Blackstocks and Cowpens.

Henry Storey married Elizabeth Cunningham (b. 1764) in Fairforest, Spartanburg County, South Carolina in about 1787 and they had four children; Arthur Cunningham Storey, Henry McCrary Storey, William Williamson Storey and James Storey.

They lived in South Carolina until December 1817, when he started to Alabama and arrived at a place on Canoe Creek, a branch of the Coosa River, Alabama, about January 23, 1818. He remained there and made two crops and in October 1820, moved to Greene County, Alabama. Henry Storey was awarded a Revolutionary War pension based on his application executed in the Greene County, Alabama, Probate Court on September 20, 1832.

His pension, certificate # 13351, File # S 32537, Alabama Agency, from the Revolutionary War Claims Act of Congress dated June 7, 1832, was for the sum of \$240 in arrears and \$60 semiannually thereafter. Records show that the last payment of pension, covering the period September 4, 1836 to March 4, 1837, was made to the Pension Agency in Mobile, Alabama, to Champ C. Marble, as attorney for the pensioner.

Henry Storey remained in Greene County, Alabama, as a farmer and was on of the founders in 1824 an Elder in the New Hope Presbyterian Church. Henry died March 19, 1837 and Elizabeth died on December 29, 1849. Both are believed to have been buried in the New Hope Presbyterian Church cemetery.

#### 2.5 Nancy Cantor

Nancy Cantor, the daughter of Jacob Cantor and \_\_\_\_\_\_ was born about 1725 in Philadelphia, Pennsylvania. The date of her death is unknown. She is presumed to have died in Virginia or Fairforest, Spartanburg County, South Carolina. She married George G. Storey, Sr. in 1744/1745 in Virginia.

Section 2.4, "George G. Storey, Sr." shows children of George G. Storey, Sr. and Nancy Cantor.

#### 2.6 James Storey

James Storey, the son of George G. Storey, Sr. and Nancy Cantor, was born June 22, 1764 in Fairforest, 96th District, South Carolina. He died on October 23, 1826 in Eutaw, Greene County, Alabama. He was buried in November 1826 in Eutaw, Greene County, Alabama, possibly in the Hebron Presbyterian Church Cemetery. James is the only son of George who did not serve in the Revolution. This was due to his age, but most boys in their teens drove supply wagons during the war, and we hope to find his record some day.

James married twice. His first wife was Catherine Cunningham, born November 3, 1768 and died June 27, 1811. They were married in about 1785/1788 in Spartanburg County, South Carolina and had eleven children.

James married Margaret White in about 1813 in Spartanburg County, South Carolina. Margaret was born about 1780 in Spartanburg, South Carolina. They moved to Greene County Alabama in either 1818 or 1823. There are no known children of James Storey and Margaret White. The will of James Storey is on file at Eutaw. It was probated with his wife Margaret White Storey and his son Henry on November 13, 1828. It is interesting to note that he bequeathed his library to his sons Samuel W. and Henry.

Dr. John Storey married Jane Cunningham on July 13, 1826. Jane Cunningham was born on June 5, 1810 in Abbeville District, South Carolina. She died April 14, 1890. John moved with his father, James Storey, to Greene County, Alabama in 1818. He was not only a doctor but also a successful farmer, ran a large country store and was Postmaster in Greene County.

Catherine [Katherine] Cunningham, a daughter of Arthur Cunningham and Mary \_\_\_\_\_\_, was born November 3, 1768 in South Carolina. She died June 27, 1811 in Eutaw, Greene County, Alabama and is buried there. She married James Storey in about 1785/1788 in Spartanburg County, South Carolina. Catherine's sister, Elizabeth, married the brother of her husband, Henry Storey.

Section 2.6, "James Storey" shows children of James Storey and Catherine [Katherine] Cunningham.

#### 2.8 Robert Storey

Robert Storey, the son of James Storey and Catherine Cunningham, was born at Spartanburg, South Carolina on May 5, 1795. He moved to Greene County, Alabama with his father's family in 1818 or 1823. Robert married Martha Smith (The name White was used in many documents but it now known to be Smith.) on May 10, 1824 in Greene County, Alabama, documented in the *Greene County Alabama Early Settlers*. William H. Storey had this to say about 'Dr. Bob': "He was a farmer, and gave medicine when he couldn't help it."

Martha Smith (White) was born about 1748 and died about 1795.

#### 2.9 Martha Smith [White]

Martha Smith [White] was born about 1748 and died about 1795. Martha Smith was the daughter of Sanford Smith & Mary Morrow.

Section 2.8, "Robert Storey" shows children of Robert Storey and Martha Smith [White].

#### 2.10 Robert Cunningham Storey

Robert Cunningham Storey, son of Robert Storey and Martha Smith (The name White was used in many documents but it now known to be Smith.), was born October 1, 1830/1831/1832 in Pickens County, Alabama. He died on June 11, 1895 in Greene County, Alabama and is buried in the Beulah Baptist Church Cemetery near Eutaw, Greene County, Alabama. It is likely that he died of typhoid just six months before his two daughters, Martha Louvenia and Florence.

Robert married Sarah Elizabeth Burnett, probably before 1870 in Alabama.

The children of Robert Cunningham Storey and Sarah Elizabeth Burnett, as enumerated on the 1880 U.S. Census, are:

Sister Storey was born \_\_\_[1877/1878]\_\_\_\_\_ and joined this church by experience and baptism in Oct. 1893. Her stay with us, like that of a spring rose, was short but admired by all. Mother and other relatives be of good cheer, the road to her is open, she cannot return but we can go to her.

#### 2.11 Sarah Elizabeth Burnett<sup>4</sup>

Sarah Elizabeth Burnett, the daughter of James Washington (Wash) Burnett and Lavinia Mahala [Linna M.] Thornton, was born August 4, 1838 in Greene County, Alabama. She died about 1915 and is buried in the Beulah Baptist Church Cemetery in Greene County, Alabama.

Sarah married Robert Cunningham Storey on March 12, 1862, in Greene County, Alabama. She is enumerated on the 1880 U.S. Census with her husband and Family.

Sarah' s father, James Washington (Wash) Burnett, was born May 20, 1811 in South Carolina and died August 7, 1874 in Greene County, Alabama. He married Lavinia Mahala [Linna M.] Thornton on June 18, 1837 in Greene County, Alabama.

Lavinia Mahala [Linna M.] Thornton was born on November 9, 1819 in South Carolina and died June 18, 1900 in Greene County, Alabama. Her parents are Luke Thornton and Sarah Reynolds.

<sup>&</sup>lt;sup>4</sup> Sarah Burnett may have been Sarah Burnett Bryan or Sarah Bryan. Online burial records for the Beulah Baptist Church Cemetery record Sarah's maiden name as Bryan. Additionally, Miriam Collins, a great granddaughter of Sarah recalls that may have been the name.

**Note:** The daughter of Sarah Reynolds and Luke Thornton, Sr. was Lavinia Mahala [Linna M.] Thornton. Lavinia married James Washington (Wash) Burnett and they were the parents of Sarah Elizabeth Burnett. Sarah married Robert Cunningham Storey and they were the parents of Martha Louvenia (Lou or Loula) Storey who was the first wife of James Pinkney Roebuck. In short, Gideon Reynolds and Mary Rogers were the great grandparents of James Pinkney Roebuck, as the well as the great, great grandparents of his first wife, Martha Louvenia Storey.

Section 2.10, "Robert Cunningham Storey" shows children of Robert Cunningham Storey and Sarah Elizabeth Burnett.

### 2.12 Martha Louvania (Lou or Loula) Storey

Martha Louvania (Lou or Loula) Storey, a daughter of Robert Cunningham Storey and Sarah Elizabeth Burnett was born October 17, 1875 and died December 9, 1895. According to her granddaughter, Miriam Collins, daughter of Nancy (Nan) Elizabeth Roebuck, Lou died of a typhoid epidemic that swept the country in the years between 1895 and 1905. In 1895, it was the sixth most prevalent cause of death in Alabama, though it was probably more prevalent than that because many typhoid deaths may have been attributed to pneumonia.

Martha Louvenia may have contracted typhoid tending to others who were ill. Typhoid also took her sister, just 10 days after her death, her father, Robert Cunningham Storey, in June of 1895, and her other siblings except for Nora Storey.

She is sited in the "Beulah Church Book," on page 252, (covering 1819-1920) in most eloquent text about her passing:

"Sister Loula Ro[e]buck 'nee' Storey died Dec. 9 1896. She was born October 17 1875; joined this church by experience and baptism Nov. 1888 and was united in marriage to Bro. J.P. Ro[e]buck Dec. 21, 1892. As a daughter she was dutiful and mother tender and affectionate. She died as she lived trusting in the Lord as is shown by the following verse which she repeated a few minutes before she died. 'Come loving Redeemer and take to Thy breast, The heart that is sighing and painting for rest; Blest Savior I am watching and waiting for Thee, Then O! let me anchor beyond the dark sea.' When the husband and children would mourn for her we would point them to this verse which indicates that she has gone to rest."

Martha Louvenia was the first wife of James P. Roebuck. According to Probate court records in Eutaw, Alabama, a marriage license application was granted by Probate Judge Wm. C. Oliver on December 19, 1892 and the marriage was solemnized on December 21, 1892. Beulah Baptist Church records show they were married at the residence of Robert Storey by Minister John G Ahsey. Their the marriage license lists "James P. Robuck" and "M. Lavinia Storey."

The children of James Pinkney Roebuck and Martha Louvenia Storey are:

It is not known whether and how long, Nancy (Nan) Elizabeth Roebuck and John Pinkney Roebuck were raised by their father after Loula's death. Family history has it that they lived they were mostly raised by a Lavinia (Vine) J. Roebuck, the sister of James Pinkney Roebuck.

# Ancestors of Martha (Mattie) Elizabeth Flanagan

This chapter shows the ancestors of Martha (Mattie) Elizabeth Flanagan Roebuck, as far as possible in maternal and paternal trees. Ancestors that are known with some degree of certainty extend back to Philip Pinkney Flanagan and his wife, Elizabeth Meador (also known as Meadows and Meadors) and James Lemuel MaHaffey and his wife, Sarah Burnett. Ancestors dating back beyond those are very probably but have not been completely verified in multiple sources.

Other first names spellings for Job may be Jobe. Other last name spellings may have been Meadors and Meadows. He is enumerated on the 1810 U.S. Census in Anson, North Carolina.

Job Meador's father was John James Rorie, Sr. (1704-1782), who was born in Essex, Virginia and died in Halifax, North Carolina. His mother was Hannah \_\_\_\_\_\_ (1710-1782). John James and Hannah \_\_\_\_\_\_ married in 1727 in Essex, Virginia.

Lucy Rorie, a daughter of William Rorie Sr. and Judah Butler, was born about 1755 in Anson, North Carolina, and died there in about 1837.

Lucy Rorie's mother, Judah Bulter, was the daughter of Joseph Wallace Bulter (1698-1763), who was born in Caroline, Virginia and died in Halifax, North Carolina.

Lucy's father, Joseph Wallace Butler, was the son of John Butler (1670-1698) and Mary Wallace (1674-1723).

Benjamin Burnett, a son of John Burnett (1702-1775) and Catherine Newbill, was born between 1720-1732 in South Farnam Parish, Essex County, Virginia and died February 27, 1798 in Strawberry Creek, Pittsylvania County, Virginia.

Frances Barnett, a daughter of John Barnett and Catherine Farrar, was born, probably, between 1735-1738. However, numerous dates are attributed to her birth in Pittsylvania County, Virginia. The dates range from 1724 to 1738. She died after September 11, 1812 in Pittsylvania County, Virginia.

Benjamin and Sarah married after October 7, 1755/1760 in South Farnam Parish, Essex, Virginia or in Goochland, Virginia.

#### 3.4 Barnett Burnett and Elizabeth (Betsy) Campbell

Barnett [Barnard] Burnett, a son of Benjamin Burnett and Frances Barnett, was born about 1757/1760 in South Farnam Parish, Essex County, Virginia. He died about October 24, 1841 and is buried in Spartanburg County, South Carolina.

Barnett Burnett's first wife was Rhoda \_\_\_\_\_. Rhoda was born in about 1772 in Essex, Virginia. They were married on December 29, 1793 in Pittsylvania County, Virginia. Rhoda probably died early 1808 or before, possibly in child birth.

Elizabeth (Betsy) Campbell was the second wife of Barnett Burnett. They were married on October 17, 1808 in Pittsylvania County, Virginia. Elizabeth Campbell was born about 1787 and was of Pittsylvania County, Virginia. Not much else is know about her.

Barnett sold his Pittsylvania County, Virginia land on March 10, 1815 (Pittsylvania County Deed Book 19:173) and apparently left for South Carolina. He purchased land in Spartanburg County o April 8, 1815.

Sarah Burnett married James Lemuel MaHaffey and had Roberta Annie MaHaffey. Therefore, Sarah Elizabeth Burnett and Roberta Annie MaHaffey were first cousins. It is these first cousins who gave birth to the wives of James Pinkney Roebuck, Martha Louvenia (Lou or Loula) Storey and Martha (Mattie) Elizabeth Flanagan.

# 3.5 Thomas MaHaffey and Hannah "Betsey" Moyer

Thomas Mahaffey and Hannah "Betsey" Moyer may be the parents of James Lemuel MaHaffey. This association is not clear but the dates and locations seem plausible.

Thomas MaHaffey came from Ireland and married the much younger Hannah Betsey Moyer. They lived most of their lives in North Carolina and moved to South Carolina just before James, their fifth and last child was born.

Thomas was born about 1750 in Lifford, Donegal, Ireland. Hannah Betsey Moyer was born about 1781 in North Carolina. They were married on November 19, 1806 in Surry, North Carolina. It is thought that both of them died and were buried in North Carolina.

# 3.7 Sarah Self

Sarah Self, the daughter of Vincent Self and \_\_\_\_\_\_, was born about 1763, probably in North Carolina and died on April 26, 1848, in Gilmer County, Georgia at the residence of her daughter, Winnie Bearden. During her life, Sarah went to Jackson County, Georgia and then to Hall County, Georgia. Sarah Self married William Flanagan in January 1783 in Anson County or Chatham County, North Carolina.

Sarah's father, Vincent Self was born about 1740, probably in Virginia. He died after 1807. Vincent went to North Carolina with his family and appears there in public records in 1761. They lived in Chatham and Anson Counties, North Carolina. This information should be considered likely but unverified.

# 3.8 Philip Pinkney Flanagan

Philip Pinkney Flanagan, a son of William Flanagan, Sr. and Sarah Self, was born on March 1, 1795 in Georgia. He died on \_\_\_\_\_ in North Carolina. He is noted in association with the War of 1812.

Philip married Elizabeth Meador [Meadors and Meadors], probably 1842 or before.

The children of Philip Pinkney Flanagan and Elizabeth Meador, not necessarily listed in the order of birth, are:

James married Miranda [Maranda] F. King on March 25, 1869 in Pleasant Ridge, Greene County, Alabama.

Miranda, a daughter of Littleberry King and Molsey Horton, was born on September 18, 1842, in Pleasant Ridge, Greene County, Alabama. Miranda died April 18, 1918 in Hull, Tuscaloosa County, Alabama.

The children of James Alexander Flanagan and Miranda F. King are:

**a.** Molsey Elizabeth (Lizzie) Flanagan, b. June 22, 1870; d. August 6, 1947; m. Roland "Arthur" Hester, Sr.

Mosley married Roland "Arthur" Hester, Sr. on November 8, 1891, at Cedar Creek Church, Franklin County, Alabama. Roland was the son of William Carroll Hester and Jane Bolton. They are both buried at Cherry Hill Cemetery, Franklin County, Alabama. Lizzie and Arthur had eight children: Grover Cleveland, James Flanagan, Carroll Roy, Vester Borden, Roland Arthur, Jr., Annie Mary, Glenn, and Edward Norris.

**b.** Mary Lula (Auntie) Flanagan, b. September 9, 1872; d. about 1935; m. Thomas Edward Norris

Mary Lula had typhoid fever in 1879 at the same time her brothers but she recovered even after the doctor said that she would not. Mary Lula married Thomas Edward Norris on December 28, 1904. They had three children: Thomas Edward, Jr., Grace, and Miranda Elizabeth.

c. James A.Flanagan, b. October 2, 1874; d. about 1879

James died of typhoid fever in 1879 at the age of five. He is buried in Pleasant Hill Cumberland Presbyterian Cemetery in Clinton, Greene County, Alabama, near his brother Berry and between his sister Annie who died in an accident 1890 and his cousin Jennie Scarbrough who died 1879 of typhoid fever.

d. Berry Coleman Flanagan, b. September 8, 1876; d. December 3, 1879

Berry died of typhoid fever at the age of three. He is buried in Pleasant Hill Cumberland Presbyterian Cemetery in Clinton, Greene County, Alabama.

e. Annie Mary Flanagan, b. October 6, 1879, and died June 9, 1890

Annie fell while running with an opened pocket knife and severed her jugular vein and bled to death. She is buried in Pleasant Hill Cumberland Presbyterian Cemetery in Clinton, Greene County, Alabama. Her headstone says, "Little Annie," aged 10 years, 8 months, and 3 days. There is an inscription that starts with "Our darling one . . ." but the rest is not legible in the available photographs. Annie was buried near her brother Berry who died of typhoid fever just two months after her birth.

f. Albert Vester Flanagan, b. October 11, 1882; d. October 13, 1939; m Lucile Hafner

Albert married Lucile Hafner on May 21, 1919. Lucile was the daughter of Adam Alexander and Mary Palmer. They had four children: Miranda Virginia, Mary Palmer, Lucille Hafner and Albert Vester. Albert is buried in Pleasant Hill Cumberland Presbyterian Cemetery in Clinton, Greene County, Alabama.

# 3.9 Elizabeth Meador

Elizabeth Meador, a daughter of James Meador and Elizabeth \_\_\_\_\_\_, was born about 1816, most likely in Greene County, Alabama. Many family history records show her last name as Meadows. However, most other records indicate a name of Meador and sometimes Meadors.

Elizabeth's parents, James Meador and Elizabeth \_\_\_\_\_ married 1804/1810, possibly in Greene County. Her parents had at least one other child, John Meador, in 1822 in Greene County.

Elizabeth married Philip Pinkney Flanagan, probably 1842 or before.

Section 3.8, "Philip Pinkney Flanagan" shows the children of Philip Pinkney Flanagan and Elizabeth Meador.

# 3.10 James Lemuel MaHaffey

James Lemuel Mahaffey, whose parents may have been Thomas MaHaffey and Hannah (Betsey) Moyer, was born about 1812 in Spartanburg, South Carolina. He died in Greene County, Alabama and is buried in the Beulah Baptist Church Cemetery near Eutaw, Greene County, Alabama. James was probably of Scotch and Irish ancestry.

James married Sarah Burnett in about 1832 in Spartanburg, South Carolina.

Sarah Burnett, a daughter of Barnett Burnett and Elizabeth (Betsy) Campbell, was born about 1819 in Virginia, possibly in the town or county of Pittsylvania. She died about 1854/1860 in Greene County, Alabama and is buried in the Beulah Baptist Church Cemetery near Eutaw, Greene County, Alabama.

Sarah married James Lemuel Mahaffey in about 1832 in Spartanburg County, South Carolina.

Section 3.10, "James Lemuel MaHaffey" shows the children of James Lemuel Mahaffey and Sarah Burnett.

# 3.12 John Mitchell Flanagan

John Mitchell Flanagan, a son of Philip Pinkney Flanagan and Elizabeth Meador [Meadors or Meadows], was born October 9, 1849 near Mantua, Greene County, Alabama. He died October 26, 1934 and is buried at the Pleasant Ridge Church Cemetery in Clinton, Greene County, Alabama.

He married Roberta Annie MaHaffey on April 8, 1875 in Greene County, Alabama. According to Greene County, Alabama probate record, Vol. F-1, page 117, they were married by Milton C. Hutton at the home of Mr. Bartlett Upchurch, husband of Aunt Minerva. John and Roberta probably lived most of their lives in Clinton, Alabama, raising three well-educated girls, unusual for the time.

Children of John Flanagan and Roberta MaHaffey:

1. Josephine Flanagan, b. January 6, 1876; d. September 17, 1911; died unmarried

Josephine graduated from Jacksonville State Normal, a teachers' college. At the time, this was a one year degree. She was a teacher and a land owner. Family records list her as having taught at Tuscaloosa City schools, probably the Stafford school.

The will of Josephine Flanagan was executed on October 16, 1903 and proved on September 26, 1912. It is recorded in the Greene County Probate Office in Book of Wills "F", pages 590-592, in Eutaw, Alabama. In her will she left a seven acre parcel of land to her parents that she purchased in January 1896. The deed for that land was recorded in the Greene County Probate Office Deed Book number seven, page 323. If her parents predeceased her, she leaves the land to her sister Clara Pinkney Flanagan.

Family stories suggest that Josephine died of a flu epidemic that also took her sister, Clara Pinkney Flanagan, four months earlier.

2. Martha (Mattie) Elizabeth Flanagan, b. August 25, 1878; d. June 29, 1941; m. James Pinkney Roebuck

Mattie taught school in Union, Alabama and in West Greene County, Alabama but it is not known if she had formal training or whether she taught regularly.

Clara was a graduate of Central College in Tuscaloosa and taught school in Tuscaloosa and Greene Counties.

Family stories suggest that Clara died of a flu epidemic that also took her older sister, Josephine Flanagan, four months later.

# 3.13 Roberta Annie MaHaffey

Roberta Annie MaHaffey (other spellings include McHaffey, MaHaffy, and possibly MaHaffie), a daughter of James Lemuel MaHaffey and Sarah Burnett, was born on December 18, 1852 near Mantua, Greene County, Alabama. She died on December 26, 1934 and is buried in the Pleasant Ridge Cemetery in Clinton, Greene County, Alabama.

Roberta married John Mitchell Flanagan in Clinton, Greene County, Alabama on April 6, 1875.

Section 3.12, "John Mitchell Flanagan" shows the children of John Mitchell Flanagan and Roberta Annie MaHaffey.

# 3.14 Martha (Mattie) Elizabeth Flanagan Roebuck

Martha (Mattie) Elizabeth Flanagan, the first child of John Mitchell Flanagan and Roberta Annie McHaffey (MaHaffey) was born August 25, 1878 in Clinton, Greene County, Alabama. She lived her life in Clinton and Union, Alabama and died June 29, 1941.

Mattie married James Pinkney (Pink) Roebuck, a widower with two children from his first marriage to Martha (Lou or Loula) Louvenia Storey. Mattie and the first wife of James Pinkney (Pink) Roebuck were second cousins. show the relationship and lineage.

According to Probate court records in Eutaw, Alabama, a marriage license application was granted by Probate Judge Amand P. Smith on December 15, 1900 and the marriage was solemnized on December 19, 1900. Beulah Baptist Church record show they were married at the residence of John Flanagan, Mattie's father, by Minister J. E. Herring.

Mattie taught school at Union and West Greene schools though there is no record that she graduated from teacher's college (usually a one year degree at the time). She came from a family of well-educated girls, unusual for the time.

Most of the first born girls of Mattie and James Pinkney (Pink) Roebuck received a full education. However, the family had difficult and poor times in the mid 1920s and, at least, Gladys Electra and Clara Pink were removed from school to work on the family farm after completing eighth grade at the Beulah school.

Mattie is recorded in the *Beulah Baptist Church Record* book as having taught Sunday School there until about 1904. We see her again in the records in 1919 when she and her daughter Jamie Clara Roebuck were part of the Beulah Woman's Missionary Society organized October 21, 1919. "The officers of this society are Miss A. G.

Chambers, President; Mrs. Mattie Robuck, Vice President,; and Miss Jamie Robuck, Sec. Treasurer."

# A.2 Ancestors of Jane A. Reynolds

Jane A. Reynolds was the wife of John R. Roebuck and the daughter of Gideon Reynolds and Mary Rogers.

Jane A. Reynolds was born about 1815 in Spartanburg County, South Carolina. Jane died young at the age of 21 or 22 on September 27, 1837. She is mentioned in her father's will -- Gideon Reynolds, lists "three grandchildren of deceased daughter, Jane A. Robuck" in his will which as probated in Greene County, Alabama on October 14, 1839.

# A.2.1 Gideon Reynolds and Mary Rogers, Parents of Jane A Reynolds

Gideon Reynolds, the son of Justus Reynolds, Sr. and Mary Wright, was born on February 2, 1776 in Frederick, Virginia and died on June 10, 1839 in Greene County,

Alabama. He is buried in the Beulah Church Cemetery in Eutaw, Greene County, Alabama.

Mary Rogers was born on June 16, 1778 in Spartanburg, South Carolina, though some records suggest she was born in Ireland. Mary died on November 29, 1860 in Greene County, Alabama. She is buried in the Beulah Church Cemetery in Eutaw, Greene County, Alabama.

Gideon Reynolds and Mary Rogers married about 1797.

The dates of their children's births require more research. Different sources have date differences of as many as eight years. The children of Gideon Reynolds and Mary Rogers are:

# A.3 Lavina Bobo

Lavina Bobo was the wife of George Roebuck (2) and the daughter of Sampson Bobo and Sara[h] (Sally) Mary Simpson. Lavina was born between 1760/1765, probably 1763, and died between 1820 and 1830, in Spartanburg County, South Carolina. Lavina (Levina) Bobo married George Roebuck in Spartanburg in about 1781 in County, South Carolina.

Sampson Bobo served in the military in Col. Brandon's Regiment South Carolina. Sampson Bobo was born about 1735/1737/1738 in possibly in Culpeper, Virginia (some records list him has having been born in France) and died April 7 or 17, 1804 in Union District, South Carolina. He is buried in Woodruff Cemetery in Spartanburg County, South Carolina. Sampson's father was Spencer Bobo [Beaubeau] and his mother was Mary Wofford. The Bobo line can be traced back to French roots with a spelling of Beaubeau and Beaubeaux.

Sara[h] (Sally) Mary Simpson was born about 1743 in Culpepper County, Virginia and died on February 16, 1816 in Spartanburg, South Carolina. She is buried in Woodruff Cemetery in Spartanburg County, South Carolina. Sarah's father was Joseph Greene Simpson (his parents were Andrew Simpson and Elizabeth Green) and her mother was Elizabeth Keech.

Sampson Bobo married Sara[h] (Sally) Mary Simpson on April 16, 1763 in Culpeper County, Virginia.

1. Will of James Storey

In the name of God Amen.

Be it remembered that I, James Story of the State of Alabama, and County of Greene, being in a very low state of bodily health, and my recovery doubtful, and believing at the same time I am sound in mind and memory, I feel it my duty to make this my last will and testament and thereby dispose of my worldly estate in the following manner.

First. It is my will and I do hereby bequeath to my beloved wife, Margaret Story my negro woman Lida, my negro woman Patt and my negro boy Frank, and my little negro girl Mary to have and to hold during the life of my beloved wife, at her death to return to my legal heirs, with the whole of their increase, if there should be any, an equal dividend to be made among all my children or legal heirs at that time, also four cows and calves, first choice in my stock also a mare called Fanny with saddle & bridle. The whole of the kitchen furniture also one trunk & spinning machine, one small cupboard with what it contains, one bed & furniture and sufficient provisions for one year.

Secondly. It is my will and I do hereby bequeath unto my beloved son John Story my negro man Will.

Thirdly. It is my will and I do here by bequeath unto my beloved daughter Elizabeth Morrow my negro woman Sall & her child.

Fourthly. It is my will and I do hereby bequeathto my beloved daughter Margaret my negro woman Fan.

Fifthly. It is my will and I hereby bequeath unto my beloved son Robert Story my negro boy Sampson and my negro girl Harriet.

Sixthly. It is my will and I hereby bequeath unto my beloved son Sam' I W. Story my negro man Joe, two cows and calves, one bed & furniture and the horse and saddle & bridle that he now claims, also the rifle gun that he now claims & my silver watch and it is my will that my wearing apparel be equally divided between my two sons S. W. Story and Henry Story.

Seventh. It is my will and I hereby bequeath unto my beloved Son Henry Story my negro girl Linda and my two negro boys Mitchell and Charles, also one bed & furniture, two cows and calves and the rifle gun he now claims, also my clock, and horse, saddle, bridle that he now claims. It is also my will that my library be lotted and equally divided between my two sons S. W. Story and Henry Story.

Eight. It is also my will that part of my real estate which lies in Pickens County and State aforesaid be equally divided between my two sons Anthony L. Story & James Story & that the fraction on the river be sold as soon as convenient that thereby money may be raised so as to make up to the aforesaid children A. L. Story and James Story a full and equal share in cash with any of the other children. It is also my will that each of the last mentioned children get one bed & furniture. It is also my will that the expense of tuition and the expense and charges of bringing the last named boys home from Kentucky, be paid out of my estate so as not to infringe on the shares of the aforesaid children. It is my will that the remainder of my estate be sold (except the stock of hogs).

And I do hereby constitute and appoint my son John Story and my son in law David Morrow, executors of this my last will and testament. In Testimony whereof I hereunto set my hand and affix my seal this thirteenth day of October eighteen hundred & twenty six and in the fiftieth year of Independence of the United Statesof America.

Supplement & the stock of hogs not to be sold but left for the support of the family.

In the name of God, Amen, I George Story of the State of South Carolina, and Spartanburg County, being In Common health of my body and my memory as perfect as I could expect considering the frailty of Body thanks be to God for his long continuation of favors to me - But calling to mind the mortality of my Body and knowing that it is appointed for all men once to die . . .

Do make and ordain this my last will and Testament That is to say principally and first of all it is my sincerest desire to resign and commit my soul that immortal part into the hands of that Blessed Jesus who suffered to redeem sinful men from everlasting torment and my body to be buried in a decent manner at the discretion

of my Executors ....

And as touching such worldly estate as it has pleased God to bless me with I give and devise and dispose of the same in the following manner and form.

lst I give and bequeath unto my well beloved Daughter, Margaret Elder the negro girl named Sall which she has now in her possession.

2dly I give and bequeath unto my well beloved son, George Story a negro girl named Fanny also one negro boy named Derre which Is to remain with his mother until he is three years old, also all my wearing apparel.

3dly I give and bequeath to my Daughter in Law, Nancy Story the one third part of twenty acres of land, one negro man named Leath which said negro she is to have for the space of ten years after my decease and at the expiration of said time the aforesaid negro Leath is to be sold and equally devided among all the children of the aforesaid Nancy Story, also twenty acres of land being a part of the third part of twenty acres of land Is a part of a tract of land laid out to George Story, Jr. lying next to the land whereon the said Nancy Story now lives and along a line of marked trees and also I give and bequeath unto the youngest son of the said Nancy Story three pounds to be put out at interest until he comes of the age of twenty one years also seven pounds to be paid for the schooling of the children of the aforesaid Nancy Story.

4thly I give and bequeath unto my son, Henry Story a negro woman named Cloe.

5thly I give and bequeath unto my youngest son James Story all the tract of land I now live on containing two hundred and forty seven acres and also one negro woman named Cede.

I don't know why there is no "6thly" - it is not present in my copy. JH

7thly I give and bequeath unto the heirs of my son Anthony Story deceased the sum of two dollars.

I likewise constitute and appoint my son James Story and my friend Hugh Means my executors of this my last will and testament and I do hereby disannull all former wills and testaments ratifying and confirming this my last will and testament in witness whereof I have hereunto set my hand and affixed my seal this eleventh day of March, one thousand eight hundred.

to mind the mortality of my body and knowing that it is appointed for all men to die, do make and ordain this my last will and testament in the manner and form following that is to say principally and first I give and recommend my soul into the hands of Almighty God who give it and my body I recommend to the Earth to be decently intered at the discretion of my Executors hoping to use again at the resurrection of the Just, and as touching all my worldly Estate which it hath pleased God to bless me with: I will that all my just debts and funeral expenses be paid first: and having no wife; and having given and bequeathed previous to this to all my Children the portion which I allotted to them but my two sons Abner Vice and Eli Vice

I now give and bequeath to my son Abner Vice one third of the tract of land where on he now lives convenient to him. The remaining part of the tract I will and bequeath to my son Eli Vice also all my personal property I Will and bequeath to my son Eli Vice; also all my personal property I excepting one feather bed I will and bequeath to my grand daughter Elvi Vice the daughter of Zery Vice my son.

The house I formaly lived in is standing on the land I bequeathed to my son Abner Vice I except which I will and bequeath to my son Eli Vice to move or dispose of as he thinks proper.

I do also nominate and appoint my two beloved sons Abner Vice and Eli Vice Executors of this my last Will and Testament. I do here by revoke and disannul all my former wills by me made before Rattifying this and no other to be my last Will and Testament. In witness where of I do hereunto set my hand and affix my seal. This the Thirty-first day of March in the year of our LORD one thousand eight hundred and thirty.
